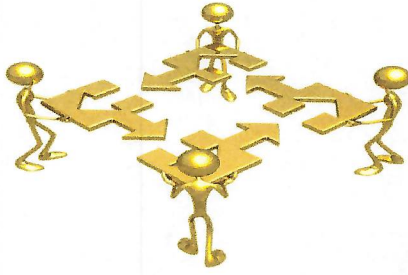

## **Dallas County Juvenile Detention and Perry Varner Educational and Treatment Facility Annual Report**

Annual report must include the following:

- The annual report must provide an assessment of the agency's progress in addressing sexual abuse.

The Dallas County Juvenile Detention and Perry Varner Educational and Treatment Facilities Assess Annually the progress in addressing abuse in its facilities. Staff trainings are conducted Annually and **Daily** briefings are held with the Administration Staff and Supervisors.

- The annual report must contain corrective actions taken (or a statement stating no corrective actions were needed).

*No Corrections were needed during this period.*

- The agency must make its annual report readily available to the public at least annually through its website.

- The agency must indicate the nature of the material redacted (personal identifying information)


