Remarks

- 3) Maps 1-7; Project estimates do not include county personnel and equipment costs performing the road construction.
- 4) Map 8; RA-DCP 24-08-20 is an undesignated Federal Aid Road Project that will utilize approximately \$100,000 remaining Federal Aid Funds and \$20,000 FHEF.
- 5) The remaining balance of FAEF will be carried over for projects in next fiscal year's (2021) CTP.
